Example #1
RP20 STRAIGHT

SWOOP RAISE
RED OAK

18" x 26"
(DOOR SIZE)

STEP 1. Select the appropriate Labor Price from the Price List:

RP20 = \$36.00 Labor per door

STEP 2. Calculate the Material Charge:

a. 18" x 26" ÷ 144 = 3.25 sq. ft.

b. Select the appropriate Material Price from the Price List:

Red Oak RP = \$7.50 per sq. ft.

c. 3.25 sq. ft. x \$7.25/sq. ft. = \$24.38

STEP 3. Add: Labor + Material = Door Price

\$36.00 + \$24.38 = \$60.38

Average Price/Sq. Ft.

\$60.38 ÷ 3.25 sq. ft. = \$18.58/sq. ft.

STEP 1. Select the appropriate Labor Price from the Price List:

RP40 = \$38.00 Labor per door

+ \$3.00 per additional panel

\$41.00 labor charge

STEP 2. Calculate the Material Charge:

a. 24 x 66 ÷ 144 = 11.00 sq. ft.

b. Select the appropriate Material Price from the Price List:

Red Oak RP = \$7.50 per sq. ft.

c. 11.00 sq. ft. x \$7.50/sq. ft. = \$82.50

STEP 3. Add: Labor + Material = Door Price

\$41.00 + \$82.50 = \$123.50

Average Price per Sq. Ft.

\$123.50 ÷ 11.00 sq. ft. = \$11.23 per sq. ft.

HOW TO ORDER

Orders may be placed in person, by mail, FAX, e-mail, using our on-line form, or via the telephone. Order specifications received via the telephone are tape recorded and repeated to the customer to insure accuracy.

Begin by carefully determining the specifications of the product you wish to order.

Please specify the:

- **JOB DESCRIPTION** (P.O. #, Name, or Address)
- **FRAME TYPE** (Quarter Round Frame or Shaker Frame.)
- **ITEM** (Raised Panel, Flat Panel, Plastic Stop, Drawer Front, Panels only, or No Panel Frame.)
- **DESIGN** (Style #, Name + Bottom Rail option.)
- **PANEL OPTION** (Swoop, Step, Hip, Tulip, Flat, PS Insert, Kerfs, V-Grooves.)
- **WOOD**
- **OUTSIDE EDGE PROFILE**
- **OUTSIDE EDGE PLACEMENT** (All 4, 4P, etc.)
- **DIMENSION SPECIFICATIONS** (Either: Opening size or Finish door size.)

OPENING SIZES are measurements that reflect the actual cabinet openings. Our computer will calculate the finish sizes from these opening dimensions. Specify Add-On Dimension.

OPENING SIZE measurement data should be # of openings, width, height, # per opening.

NOTE: The difference between opening size and finish size is the "ADD ON" Dimension. Be sure the edge profile and the Add-On Dimension selected are compatible.

FINISH SIZES are measurements that reflect the final size of the product.

FINISH SIZE measurement data should be: QUANTITY, WIDTH, HEIGHT

NOTE: Small sizes of certain designs may make design alteration necessary.

- **SPECIAL MILLING INSTRUCTIONS** (Special Parts, Color Match, or Grain Match).

STANDARD COLOR TONE (NO EXTRA CHARGE)

Select individual parts of a product by their face side color so that there is not a sharp face side color contrast between any parts of the same unit. Moderate face side color variations are allowed. Color variations are allowed on the back side.

MULTI-DOOR COLOR MATCH (ADD-ON CHARGE)

This is an extension of the "Standard Color Tone Policy. Slight face side color variations are allowed. Once the complete order is assembled, then the entire order is compared to itself, so as to achieve a more uniform face side color tone. Color variations are allowed on the back side.

MULTI-PANEL GRAIN MATCH (ADD-ON CHARGE)

This applies only to doors with multiple vertical panels. It requires maintaining the integrity of the panel grain pattern by cutting all the panels for one door from one panel blank and then assembling the individual panel parts in their original sequence.

- **SHIPPING INSTRUCTIONS** (Carrier selection, special routing and payment information.)

PAYMENT TERMS:

Invoices are due and payable upon receipt. Pre-paid orders will receive a 5% product discount. C.O.D. shipped orders will receive a 2% product discount.

METHOD OF PAYMENT:

NEW ACCOUNTS – Pay with cash, cashiers check, money order, or VISA/MASTERCARD.

ESTABLISHED ACCOUNTS – Pay with cash, company check or VISA/MASTERCARD.

VOLUME ESTABLISHED ACCOUNTS – May qualify for additional terms of total due 30 days, 0% discount.

SHIPPING

Products shipped will be carefully packaged and protected. Prices are F.O.B. Oklahoma City, Oklahoma, and will be shipped, as customer directs, via common carrier. Any special routing instructions should accompany the order information. Customer is responsible for freight charges. Hutchinson Products assumes no responsibility for loss, damage, or delay during shipment. It is the responsibility of the receiving party to inspect each shipment for freight damage and resolve the matter with the carrier directly.

CLAIMS

Claims, including shortages, must be made within five days of receipt of merchandise. Any product claimed to be of defective material or workmanship must be returned to Hutchinson Products for inspection. Any adjustments will then be made, subject to the provisions of the Hutchinson Products Limited Warranty.

CHANGES OR CANCELATIONS

Products are manufactured to the customer's specifications. Therefore, changes or cancellations of orders in process are subject to charges, to be determined by Hutchinson Products, at the time of request.

LIMITED WARRANTY

All products are sanded and unfinished. Standard products are guaranteed by Hutchinson Products to be of good workmanship, free of defects which would render them unserviceable or unfit for the use which they are intended. Natural variation in the color or texture of the wood or the seams in plywood panels are not to be considered defects. A warp or bow, not to exceed 1/8 inch, shall not be considered a defect. Doors wider than 20 inches or longer than 40 inches are not warranted unless manufactured as multi-panel doors. Slab Drawer Fronts larger than two square feet are not warranted at all. Products manufactured with customer supplied material are not warranted against any material related defect.

This warranty covers the replacement or repair, at Hutchinson's option, of any defective standard product, as originally ordered, for a period of 2 years (24 months) from date of invoice, when accorded reasonable treatment by the purchaser. This warranty is void unless all surfaces are thoroughly and timely painted, varnished, or sealed to prevent undue absorption or release of moisture.

This warranty does not cover, and Hutchinson Products assumes no responsibility for, any damage incurred as a result of storage, handling, original installation and finishing or replacement installation and re-finishing. Hutchinson Products' liability under this warranty shall be limited to the original invoice price of the product. There are no further warranties of any kind, expressed or implied.
